Terms & Conditions

EFFECTIVE DATES: March 14, 2025 – March 16, 2025

BK Big Fish Record Weight Prize

Burger King Big Fish Tournament 2025

\$100,000 USD per Eligible Species

a. DEFINITIONS:

- i. "Eligible Location" shall mean those waters in and around the Cayman Islands eligible for the "Cayman Islands All Tackle Record" consideration per Tournament rules; and
- ii. "Eligible Species 1" shall refer to dolphinfish as recognized by the IGFA; and
- iii. "Eligible Species 2" shall refer to wahoo as recognized by the IGFA; and
- iv. "Eligible Species 3" shall refer to yellowfin tuna as recognized by the IGFA; and
- v. "IGFA" shall mean the International Game Fishing Association; and
- vi. "Tournament" shall mean the Burger King Big Fish Tournament 2025 to be held from March 14, 2025 through March 16, 2025,
- vii. "Tournament Boat" shall refer to a boat officially registered into the Tournament; and
- viii. "Tournament Participant" shall mean a person officially entered in the Tournament.

b. If:

- i. the largest Eligible Species caught during the Tournament by a Tournament Participant on a Tournament Boat during the Tournament dates and times in accordance with all IGFA and Tournament rules establishes a new "Cayman Islands All Tackle Record" for any Eligible Species class, as certified by the applicable governing bodies that establish and certify said record; and if
- ii. Tournament Participant have complied with the terms and conditions of this contract the Official Rules.

c. In order to be eligible for a prize, the "Cayman Islands All Tackle Record" Eligible Species must be caught in the manner prescribed by the IGFA international angling rules. Any

variance in this condition must be with the express written consent of SCA prior to the start of the Promotion. Ties of existing records will not be recognized. Any new record must exceed the existing record by one half of one percent (0.5%) per IGFA rules.

d. All Tournament waters (i.e., the Eligible Location) must have been open to the public for fishing for at least one (1) year immediately prior to the Promotion, and must have an existing certified "Cayman Islands All Tackle Record" for the Eligible Species 1, Eligible Species 2, and Eligible Species 3 recognized by the appropriate Cayman Islands record keeping authority for the Eligible Species 1, Eligible Species 2, and Eligible Species 3.

e. Prize Claimant Obligations:

i. All certification requirements will be the exclusive responsibility of the potential winner, and must be completed within a reasonable period of time, but not to exceed ninety (90) days.

ii. If there is a potential winner, The Winner must be complete an Winners Affidavit in its entirety and submitted to Burger Holdings Ltd. within exceed sixty (60) days from the conclusion of the Tournament unless agreed to in writing.

iii. Any potential winner, regardless of issue, must submit to and pass, in a conclusive manner, a polygraph examination administered by a licensed polygraphist as a condition precedent to prize payment consideration.

f. Eligible Tournament Participants: Only those Tournament Participants officially entered in the Tournament who comply with the terms and conditions of this contract the Official Tournament Rules shall be eligible to compete for a prize.
